Grit and Grinding On

An Overview from Nick Bowdish President & CEO



Siouxland Ethanol resumed production on May 18, 2020 as motor fuel demand recovered nationwide after being down 45%. The company used its thirty days of

downtime to proactively inspect and perform maintenance on several pieces of equipment, machinery and tanks that time would not allow for during our typical biannual plant outages. The team was pleased to confirm the strong mechanical integrity and expected longevity of several of the plant assets.

The impact of the pandemic is far from over on our business and our in-

dustry. For the past 3 years, the US ethanol industry had 1 BGY of production capacity that was not utilized. The pandemic has increased the excess production capacity of the industry to approximately 3.5 BGY with the setback in total motor fuel consumption and the nationwide penetration rate of ethanol into gasoline remaining stagnant. Ten percent ethanol blends will not sustain \$3 per bushel cash corn bids – what blend are you using in your car?

Siouxland Ethanol remains in a strong financial position with \$23M of working capital, a \$40M unused line of credit, and no change in long-term debt. During the quarter, Siouxland Ethanol received its \$10M investment back with interest from Siouxland Renewable Holdings after that company ceased its strategy of acquiring another ethanol plant.

The combined heat and power addition to the Jackson plant continues to be on budget and on schedule with completion expected in November. As of June 30, 2020, Siouxland Ethanol had \$10.7M left to fully fund all of its committed capital projects. It is imperative to commission these projects as the company differentiates itself from the pack in order to withstand the volatility and downturns in average industry crush margins. The Board of Directors deserves recognition and credit for allocating capital to these critical reinvestments – it is the primary reason Siouxland Ethanol is profitable year-todate.

I want to thank all our employees for their above and beyond efforts this past quarter. As Pat Baker points out, the team does so much more than manufacture fuel and animal feed. It is because of their grit that Siouxland Ethanol is grinding on!

FINANCIAL HIGHLIGHTS

Comparison of operations three months ended:

- The severe effects of COVID-19 pandemic on fuel demand and reduced ethanol netbacks resulted in quarterly revenues nearly 48% below the same fiscal quarter 2019
- The Company suspended operations for ~30 days and sold ~33% less ethanol with netbacks down ~22% for the quarter over the prior quarter 2019.
 Co-product sales off similar volumes, though prices down only ~4% over prior quarter 2019

Comparison of operations six months ended:

- Fiscal YTD sales down primarily the result of ~6% reduced sales volumes and 7% lower ethanol netbacks, however distillers grains prices were slightly better than prior year to date
- The reduced sales volumes noted above, along with reduced crush margins, resulted in gross profits down over same fiscal period 2019
- Working capital remains strong at \$23.4MM, up \$8.4MM over last quarter ended March 31, 2020
- 15 units traded during the quarter ending June
 30, 2020, averaging \$15,667/unit


